## **BAD CHECK CRIME REPORT**

### **STEP 1 – CONFIRM ELIGIBILITY**

The following types of checks are	NOT eligible for the program	<u>n</u> :

# SAMPLE "STATUTORY NOTICE" Date:

Dear Check Writer:
You are hereby notified that check numbered in the face amount of \$ issued by you on drawn upon Bank/Credit Union, and payable to, has been dishonored. Pursuant to Indiana law you have 10 days from receipt of this notice to ender payment of the full amount of the check, plus a service charge which may not exceed the greater of \$27.50 or 5% (not more than \$250.00) of the amount due.
Unless this amount is paid in full within the time specified above, we may turn over the dishonored check and all other available information relative to this incident to the Noble County Prosecuting Attorney for potential criminal prosecution.

### **BAD CHECK VICTIM INFORMATION**

As a victim of a bad check, you may file this report with the Noble County Prosecuting Attorney, provided there is sufficient information and that the check meets all eligibility guidelines. The Noble County Prosecuting Attorney's Office will seek full restitution for victims whenever possible; however, please keep in mind that the Noble County Prosecutor's Office can make no recovery guarantees. By submitting the check to the Noble County Prosecuting Attorney, you surrender control of the check to criminal process and forego the opportunity to pursue civil debt collections at that time.

Check writers are encouraged to make payments in full. Should a partial payment be received, the payment will be allocated to the victim. "Restitution" refers to the face value of the all checks listed on this report.

A check will be determined NOT eligible and returned to you to pursue a civil remedy, if a filed check is later determined to be:

- A stop payment check where the issuer acted in good faith and with reasonable cause in stopping payment.
- A check issued by someone not competent or of legal age.
- A check dishonored due to bank error or failure to notify the check writer of bank adjustment of a check.
- A check issued to pay an obligation arising from an illegal transaction.

## WHAT TO DO AFTER MY BAD CHECK CRIME REPORT IS FILED WITH THE NOBLE COUNTY PROSECUTING ATTORNEY

- IF YOU ACCEPT PAYMENT DIRECTLY FROM CHECK WRITER AFTER SUBMITTING THE "BAD CHECK CRIME REPORT" YOU MUST NOTIFY THE PROSECUTOR'S OFFICE WITHIN 24 HOURS.
- You may contact the Noble County Prosecutor's Office for case updates.
- Please allow a minimum of 90 days to pursue restitution.
- If the check writer does not comply, the case may be reviewed for possible criminal prosecution.
- If we are unable to recover restitution and/or the check is not "eligible" for prosecution, you will be notified so you may pursue civil remedy.

#### FILING INSTRUCTIONS

- 1. Fill out the "Bad Check Crime Report" completely and return to the Noble County Prosecutor's Office either by US Mail or Email to badchecks@nobleco.us.
- Attach copies of all checks (including the front and back of the checks) and all supporting documents including the CERTIFIED MAIL RETURN RECEIPT OR UNDELIEVERED LETTER, COPY OF "STATUTORY NOTICE", ETC.
- 3. Be sure to send all of the above either by US Mail or Email as mentioned above.
- 4. Once a case has been filed, the Noble County Prosecuting Attorney's Office must be informed of ALL restitution payments.
- 5. <u>IF YOU ACCEPT PAYMENT DIRECTLY FROM CHECK WRITER AFTER SUBMITTING THE "BAD CHECK CRIME REPORT" YOU MUST NOTIFY THE PROSECUTOR'S OFFICE WITHIN 24 HOURS.</u>
